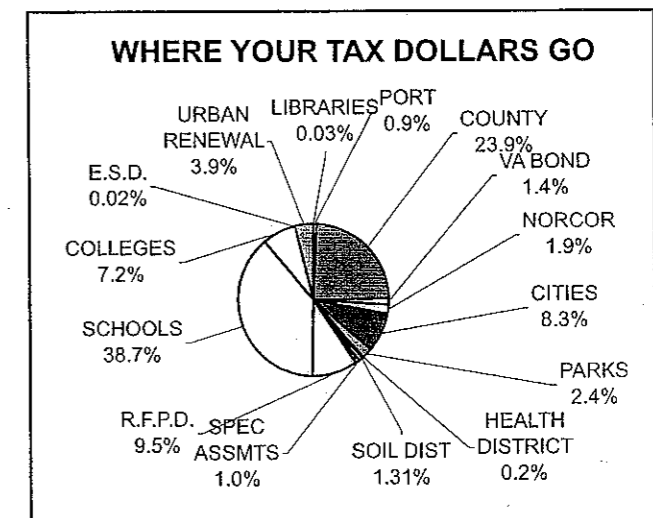

This summary is designed to provide information about the current Assessment and Tax Roll. More detailed or specific information is available from our offices, located at the County Courthouse at 511 Washington St. #208, in The Dalles, OR.

If you have questions concerning property you own or more general questions about the property tax system, you are welcome to discuss your situation with a member of our staff. The records and services of the Assessor's Office are open to you, the public, and you are encouraged to discuss your assessment questions with this office.

Ad Valorem taxes are based on the Taxable Assessed Value of your property, as established in conformance with Ballot Measure 50. Those taxes provide funds for the operation of schools, cities, fire districts, and other taxing districts. Tax rates are expressed in dollars per thousand of assessed valuation.

Section 11b, Article XI of the Oregon Constitution (Ballot Measure No. 5) limits the amount of property taxes that can be assessed against any individual property to \$5.00 per thousand of Real Market Value for education, and \$10.00 per thousand of Real Market Value for general government, excluding bonded indebtedness.

The Assessor does not tax, but values your property through methods prescribed by state laws and regulations. The Assessor does not determine the amount of money your taxing district receives. To control spending, you should take an active interest in local budget meetings and elections. You are, in effect, purchasing services with your tax dollars.

**PAYMENT OF TAXES** - Taxes based on any January 1st assessment are due and payable on or before November 15th; and are subject to a 3% discount if paid in full at that time -OR- TAXES are due on the following dates; 1st third on or before November 15th; 2nd third on or before February 15th; 3rd third on or before May 15th;

Interest will be charged on any payment after the installment due date for the schedule you choose. The interest rate is determined by statute. By law, the Tax Collector must credit your property tax payments to the earliest year for which taxes are due. In order to receive a discount on your current year's bill, all prior year's taxes, penalties and interest must be fully paid.

If the total property tax is less than \$40.00, no installment payment of taxes shall be allowed. A minimum partial payment of at least \$10.00 may be made at any time.
