**Wasco County Community Corrections is releasing the following information pursuant to ORS 181.585, which allows law enforcement agencies to release information necessary to promote community safety.**

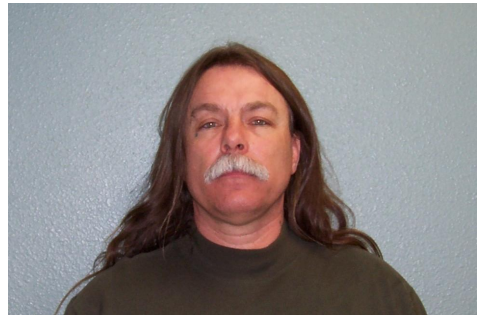

### **Currently on supervision for:**

Assault IV Felony, Failure to Register as a Sex Offender; Lewallen was convicted in 1981 for Unlawful Sexual Intercourse with a Minor and Oral Copulation of a Minor. He was also convicted of Rape I, Forcible Sodomy, Indecent Exposure and Attempted Child Stealing in 1984. The

offender's post-prison supervision expires in March of 2010.

### **TARGET VICTIMS:**

Records indicate the offenders victims have been both minors and adult females.

### **CONDITIONS OF SUPERVISION:**

- No contact with minors without permission from the supervising officer
- Do not go to places where minors are likely to congregate
- No pornography
- Submit to random polygraph and plethysmograph testing
- Participate in a sex offender and/or a domestic violence treatment program
- Not to consume or possess intoxicants
- Do not participate in intimate relationships without permission from the supervising officer
